

Historically, employee service awards programs were positioned as a company benefit, part of a total reward and recognition package. They were, and in many cases still are, a very transactional, automated process. In these scenarios, employees may have received an award on their desk, or in the mail, on their anniversary date. A few employees may have gotten their award in a lackluster team presentation. Companies typically administered these programs themselves or relied on a service award vendor. In the past, service awards for employees usually included certificates, plagues, and collar pins to symbolize an employee's years of service.

Recipes to Try

Ok as some of you know I just received an air fryer for Christmas so I will be posting my very first recipe I used in my air fryer and it came out great. Air Fryer Buffalo Chicken Wings Rating: 4.8 stars

Push the deep fryer aside and pull out the air fryer instead next game day. There is no need to add all that oil when you can achieve crispy wings straight out of the air fryer. Serve with celery sticks and ranch dressing, if desired.

Ingredients

- 2 ½ pounds chicken wings
- 1 tablespoon olive oil
- 2/3 cup cayenne pepper Sauce
- ½ cup butter
- 2 tablespoons vinegar
- 1 teaspoon garlic powder

Directions

- 1. Preheat air fryer to 360 degrees F.
- 2. Place wings in a large bowl.

 Drizzle oil over wings and massage until chicken is evenly coated.
- 3. Place ½ the wings in the air fryer basket and cook for 25 minutes. Use tongs to flip wings and cook 5 more minutes. Transfer cooked wings to bowl. And repeat with remaining wings.
- 4. Combine hot pepper sauce, butter, vinegar, garlic, and cayenne pepper in a small saucepan over medium heat. Stir and keep warm until wings are done.
- Pour sauce over cooked wings.
